1. Purpose and Authority

This Author Copyright and Privacy Statement affirms the intellectual property rights of authors and defines the privacy protections governing personal and research data throughout the AI Governance Review publication lifecycle.

This Statement is issued under the authority of The Center for Ethical AI and is binding on all editorial, review, and governance operations of AIGR. It operates in conjunction with, and is subordinate to, the Governed Data Boundary Policy (GDBP) and the Transparent AI Review Charter (TARC).

2. Copyright Ownership and Licensing

Author Ownership

Authors retain full and exclusive copyright to their submitted and published works. Submission to AIGR does not constitute a transfer of ownership.

Publication License

Upon acceptance, authors grant AIGR a non-exclusive, perpetual license to publish and distribute the work under the Creative Commons Attribution–Noncommercial 4.0 (CC BY-NC 4.0) license unless an alternative license is requested and approved in writing.

AIGR does not sell, sublicense, or commercially exploit author content.

3. Proof of Authorship and Precedence

Each submission is time-stamped and SHA-256-hashed at intake. The resulting hash is recorded in the Governance Ledger as immutable proof of authorship and submission precedence.

This record may be used by authors to establish priority or resolve authorship disputes.

4. Privacy and Data Protection

Personal Data Handling

All personally identifiable information is processed in accordance with the principles of ISO/IEC 27701 and the GDPR, including data minimization and purpose limitation.

Anonymity and Review Modes

By default, manuscripts are anonymized for both AI and human reviewers. Authors may elect alternative review modes as permitted under TARC.

Infrastructure Safeguards

All systems employ zero-trust access controls, encrypted communication channels, and role-based permissions aligned with the GDBP.

5. AI Use Transparency

Where AI systems are used in the review process, authors are informed through:

- a) This Statement.
- b) The Transparent AI Review Charter.
- c) A Peer Review Declaration is published with each accepted article.

No manuscript content is retained, reused, or incorporated into AI model training.

6. Author Rights and Choices

Authors retain the right to:

- a) Request verification of data deletion.
- b) Request a copy of their governance log.
- c) Select from approved review modes.
- d) Petition for correction, redaction, or withdrawal where justified.

Requests are reviewed by the Editorial Governance Board within 30 days.

7. Breach Notification

In the event of unauthorized access, data loss, or policy violation affecting author data, affected authors will be notified within 72 hours. Incidents and corrective actions are disclosed in the annual governance transparency report.

8. Amendments and Version Control

Material changes to this Statement require approval by the Editorial Governance Board. All versions are dated, archived, and publicly accessible.
